Introduction to Facilities Standards

It is the position of the Goodhue County Education District (GCED) districts (Cannon Falls, Goodhue, Kenyon-Wanamingo, Lake City, Red Wing and Zumbrota-Mazeppa) to provide classrooms and other facilities in which students with disabilities receive instruction, related services and supplementary aids in rooms essentially equivalent to the regular education program in order to provide an atmosphere that is conducive to learning as well as meet the student's special physical, sensory and emotional needs.

All necessary special equipment and instructional materials will be provided for proper instruction, related services and supplementary aids and services in accordance with Minnesota rules.
